3. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, Cap 205, and the Regulations made under the Act, and is open to all bidders
4. Bidding shall be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act, Cap 205, Insurance Act, Cap 191 and the Regulations made under the PPDA and Insurance Regulatory Authority and is open to all bidders
